ORDER DIRECTING JOINT PROPOSED SCHEDULE

Issue Date: May 12, 2020

Effective Date: May 12, 2020

On March 2, 2020, Missouri-American Water Company (MAWC) filed an application to change its Infrastructure System Replacement Surcharge (ISRS). By statute, the Commission must issue its order to be effective no later than June 30, 2020.¹

The Staff of the Missouri Public Service Commission (Staff) filed its recommendation to approve MAWC's application. The Office of the Public Counsel (Public Counsel) filed an objection to Staff's recommendation and requested a hearing.

In order to expedite a schedule in light of the pending statutory deadline, the Commission will direct the parties to jointly propose a procedural schedule for pre-filed testimony and an evidentiary hearing, or for briefing and oral argument. The Commission requests the parties include the following as part of the procedural schedule:

- Date of submission of a Joint Stipulation of Facts; and
- June 17, 2020 – the likely Agenda date for submission of an order.

THE COMMISSION ORDERS THAT:

1. No later than May 19, 2020, the parties shall submit a joint proposed procedural schedule as described in the body of this order.
