On April 23, 2020, Missouri-American Water Company (MAWC) filed sheets under Tariff Tracking No. JW-2020-0185 to make the treatment of the customer service lines in MAWC's service area consistent with the rest of its service areas. The tariff sheets have an issue date of April 23, 2020, and an effective date of May 23, 2020.

On May 11, 2020, the Commission's Staff filed a motion asking the Commission to suspend the tariff sheets and create a docketed case, stating that although the Staff did not necessarily have any serious concerns about the filing, the Staff needed further opportunity to review the tariff sheets. The Commission will order MAWC to expeditiously file any objections or responses to Staff's motion.

THE COMMISSION ORDERS THAT:

1. If MAWC wishes to file a response or objections to Staff's motion to suspend the tariff sheets submitted under Tariff No. JW-2020-0185, MAWC shall do so no later than May 14, 2020.
