ORDER CANCELLING IVOIP REGISTRATION

On April 30, 2020, the Commission's Staff filed a recommendation asking the Commission to cancel the IVoIP Registration of ESCO Technologies, LLC. The Commission granted ESCO Technologies that Registration in File No. DA-2015-0237, on April 9, 2015.

Staff states in its motion that ESCO Technologies sent a letter to Staff on April 18, 2020, indicating its desire to relinquish its Registration. Staff indicates ESCO Technologies' request to cancel its Registration is in compliance with Commission Rule 20 CSR 4240-28.011(3), and asks the Commission to cancel that Registration.

On May 1, 2020, the Commission issued an *Order Establishing Time to Respond*, allowing parties until May 11, 2020, to object or to request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a Registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's motion, the Commission finds that the Registration granted to ESCO Technologies shall be canceled.

THE COMMISSION ORDERS THAT:

- The Registration to provide IVoIP services granted to ESCO
 Technologies in File Number DA-2015-0237, is canceled.
 - 2. This order shall become effective on June 13, 2020.
 - 3. This file may be closed on June 14, 2020.
