**ORDER DENYING MOTION FOR RECONSIDERATION
AND REQUEST FOR ORAL ARGUMENTS**

Issue Date: May 13, 2020

Effective Date: May 13, 2020

On April 29, 2020, the Commission issued its Order Setting a Procedural Schedule Including a Limited Hearing on Remand. On May 7, 2020, Spire Missouri Inc. (Spire Missouri) filed a Motion for Reconsideration and Request for Oral Argument. Spire Missouri argues that the Commission misinterpreted the Court of Appeals' mandate and is inappropriately limiting the proceedings. Spire Missouri also requests oral arguments to further explain its position to the Commission.

The Court of Appeals reversed the Commission's Report and Order and remanded it to the Commission with specific directions to remove "the cost incurred to replace cast iron and bare steel mains and service lines not shown to be worn out or deteriorated" and

refund “that amount” expeditiously.¹ The Commission interprets that language as requiring it to hold only limited proceedings to determine the amount to be refunded.

The Commission finds that it has interpreted the Court of Appeals’ mandate correctly and will deny Spire Missouri’s motion for reconsideration. Additionally, the Commission will deny the request for oral arguments.

THE COMMISSION ORDERS THAT:

1. Spire Missouri Inc.’s Motion for Reconsideration and Request for Oral Argument filed on May 7, 2020, is denied.
2. This order is effective when issued.
