On March 18, 2020, the Commission issued an Order Granting Partial Waiver that allowed The Empire District Electric Company and The Empire District Gas Company to begin transitioning from an Empire-Liberty Utilities dual brand to a Liberty Utilities brand. One of the conditions placed on that order was that the companies keep Staff, interested stakeholders, and the Commission apprised of developments, including making a presentation to the Commission regarding its new brand and customer communication plan. Liberty Utilities has informed the Commission that it will make such a presentation at the Commission's June 3, 2020, agenda meeting.
