On May 11, 2020, the Missouri Department of Conservation (MDC) filed a motion to modify the requirements of paragraph 9 of Appendix A of the Stipulation and Agreement Concerning Wildlife Issues previously approved by the Commission in the June 19, 2019 Report and Order. MDC states that this provision relates to a traffic count survey that it requested be included in the agreement. MDC states that its staffing priorities have changed since entering into the agreement and it no longer wants to move forward with the survey.

MDC stated that it had discussed this proposed modification with the other parties to the case and no party objects. The Commission will set a time for responses to the proposed modification.

THE COMMISSION ORDERS THAT:

1. Any response to the Motion to Modify Stipulation shall be filed no later than May 21, 2020.
2. This order is effective when issued.
