An evidentiary hearing regarding the net book value of Port Perry Service Company is scheduled for May 19-20, 2020. A prehearing conference is scheduled for May 15, 2020.

The procedural schedule sets May 14, 2020, as the deadline to file the List of Issues, Order of Witnesses, Order of Cross-Examination, and Order of Opening Statements. Staff requested the deadline be extended until after the prehearing conference to allow the parties to clarify their issues list.

Staff states that it contacted the other parties and none objected to its requested extension. Based on the representation of counsel, the Commission will consider the request for additional time unopposed. The Commission finds that the unopposed request for additional time is reasonable and will grant it.
