On May 13, 2020, the Commission issued an order entitled *Order Approving Motion for Variance and Approval of Tariffs*. That order approved certain variances requested by The Empire District Electric Company, The Empire District Gas Company, Liberty Utilities (Missouri Water) LLC, and Liberty Utilities (Midstates Natural Gas) Corp., all Liberty Utilities companies (collectively Liberty Utilities), but, contrary to the title of the order, did not approve the tariffs proposed by Liberty Utilities. Those proposed tariffs remain pending. Accordingly, the Commission will correct the title of its May 13 order *nunc pro tunc*.

1. The title of the order issued by the Commission is corrected *nunc pro tunc* to read *Order Approving Motion for Variance*.
