ORDER SETTING TIME FOR RESPONSES

On May 13, 2020, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed an application to modify its Demand-Side Management Portfolio and Plan for years 2019-21 (MEEIA 2019-21 Plan) in order to extend the effective date through December 31, 2022. Ameren Missouri also asks for approval of variances from certain Commission rules, as well as approval of a proposed procedural schedule if an objection is made to the modified plan.

Pursuant to 20 CSR 4240-20.094(5)(A)5 and 6, the parties have 30 days to file an objection. If there is no objection, the Commission will make its decision within 45 days of the filing. If an objection is made, then the Commission will provide an opportunity for hearing, which Ameren Missouri has requested. Therefore, the Commission will set a time for objections to the request for modification of the MEEIA 2019-21 Plan. The Commission will also direct the parties to indicate any objection to Ameren Missouri's requested variances and proposed procedural schedule.

THE COMMISSION ORDERS THAT:

1. Any objection to the Application for Modification of Demand-Side Management Plan, Approval of Associated Variances, and Adoption of a Procedural Schedule shall be filed no later than June 12, 2020.
2. This order is effective when issued.
