### ORDER REJECTING TARIFF TO CHANGE FUEL ADJUSTMENT RATES

Issue Date: May 21, 2020 Effective Date: May 31, 2020

On April 1, 2020, The Empire District Electric Company, a Liberty Utilities company (Liberty-Empire) filed a tariff sheet proposing to increase the company's fuel adjustment rates, as provided by Commission Rule 20 CSR 4240-20.090(8). Liberty-Empire proposes to increase the fuel adjustment rates per kilowatt hour (kWh) to \$.00119 for primary service and \$.00121 for secondary service, effective June 1, 2020.1

On May 1, 2020, Staff recommended the Commission issue an interim rate adjustment order to approve Liberty-Empire's substitute tariff sheet to be effective on June 1, 2020, subject to true-up and prudence review. On May 11, 2020, the Office of the Public Counsel filed a pleading opposing Staff's recommendation. OPC contends the proposed tariff sheet impermissibly includes coal inventory adjustments related to retirement of the Asbury generating facility. At the direction of the Commission, Staff and

Liberty-Empire responded to OPC's objection. Liberty-Empire contends the adjustments at issue were properly recorded in compliance with the company's tariff. Staff responded that issues posed by retirement of Asbury are premature and can be better addressed "once a decision is rendered regarding the date that costs and revenues from Asbury should no longer be included in [Liberty-Empire]'s FAC."

OPC's objection raises an issue about whether the proposed fuel adjustment rates comply with Liberty-Empire's fuel adjustment clause tariff. As required by Commission Rule 20 CSR 4240-20.090(8)(H), the Commission will reject the substitute tariff, Tariff No. JE-2020-0171, suspend the timeline for the fuel adjustment rate filing in this case, set a date for a prehearing conference, order the parties to propose a procedural schedule, and order Liberty-Empire to file a tariff sheet to implement interim adjusted fuel adjustment rates to reflect any part of the proposed adjustment not now in question.

Because the proposed substitute tariff indicates an effective date of June 1, 2020, the Commission will make this order effective on May 31, 2020.

#### THE COMMISSION ORDERS THAT:

- 1. The proposed substitute tariff sheet, assigned Tariff No. JE-2020-0171, is rejected.
- The timeline of Liberty-Empire's fuel adjustment rate filing in ER-2020-0311 is suspended.
- 3. A prehearing conference is scheduled for 1:15 p.m. on June 8, 2020, to be conducted by WebEx conference. The WebEx link and access code will be distributed by email to all counsel of record.

- 4. The parties shall file a proposed procedural schedule no later than June 18, 2020.
- 5. Liberty-Empire shall file any revised tariff sheets necessary to implement interim fuel adjustment rates consistent with uncontested components of Liberty-Empire's proposed fuel adjustment rates.
  - 6. This order shall be effective on May 31, 2020.
