During the conference, the parties requested that the start of the hearing be postponed to Wednesday, May 27, 2020, so that they may continue having settlement discussions. The Commission will grant the request and delay the start of the hearing.

Additionally, the parties mutually agreed that there was no cross-examination for the Spire Missouri Inc. witnesses whose prefiled testimony is expected to be entered only as an offer of proof. Thus, those witnesses are excused from appearing at the hearing.

1. The hearing on remand originally scheduled to begin May 26, 2020, is postponed to begin at 9:00 a.m. on May 27, 2020.
