The Commission issues this video service authorization to correct an error in the spelling of the City of Oronogo in the Video Service Authorization issued and effective on May 16, 2025.

On May 2, 2025, Cable One, Inc. d/b/a Sparklight, pursuant to Section 67.2679.7, RSMo 2016, filed a Notice of Change Application seeking to change video service to the following political subdivisions:

The Commission has reviewed the application filed by Sparklight and finds that it and the attached affidavit comply with the filing requirements set forth in Section 67.2679.7, RSMo 2016.

### THE COMMISSION ORDERS THAT:

1. Sparklight's May 16, 2025 grant of authority to provide video service in the franchise area of each political subdivision set forth in the application and restated above is corrected and remains in effect.

2. Sparklight continues to be granted authority to construct a video service

network along, across, or on public rights-of-way for the delivery of video service to the extent the video service provider or an affiliate did not otherwise possess a valid authorization to occupy the public rights-of-way.

3. This order shall become effective when issued, after which this file shall be closed.
