NOTICE OF RULINGS AT PROCEDURAL CONFERENCE

Issue Date: June 13, 2025

On June 13, 2025, the Commission held a procedural conference to discuss applications to intervene, submission of a proposed procedural schedule, and Union Electric Company d/b/a Ameren Missouri's request for a protective order. The Regulatory Law Judge granted the intervention applications of Missouri Industrial Energy Consumers, Google LLC, Renew Missouri Advocates, Sierra Club, and Amazon Data Services, Inc. There were no objections to those interventions.

Ameren Missouri was granted until June 23, 2025, to respond to Evergy Missouri Metro and West's application to intervene. Evergy Missouri Metro and West have until June 27, 2025, to reply to any Ameren Missouri response to their intervention application.

The parties were granted until June 23, 2025, to file a proposed procedural schedule.

A deadline of June 17, 2025, was established for any responses to Ameren Missouri's request for a protective order.
