ORDER DIRECTING RECOMMENDATION OF REVISED TARIFF

On May 29, 2025,¹ the Commission issued a *Report and Order Approving Addendum to Territorial Agreement* in this matter. Among other things, that order directed The Empire District Electric Company d/b/a Liberty to submit revised tariff sheets to reflect the change in its certificated electric service area in Christian County resulting from the order.

On June 23, Liberty filed a tariff sheet, bearing an effective date of July 23, and assigned Tracking No. JE-2025-0177, purporting to comply with the terms of the Commission's May 29th order.

The Commission will ask its Staff to file a recommendation advising the Commission as to whether the submitted revised tariff sheet complies with the Commission's May 29th order.

1. Staff shall file a recommendation regarding Liberty's revised tariff sheet (Tracking No. JE-2025-0177) no later than July 8, 2025.
