**ORDER APPROVING PGA TARIFF**

Issue Date: May 28, 2020

Effective Date: June 1, 2020

On May 14, 2020, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed a tariff sheet to reflect changes in its Purchased Gas Adjustment (PGA) factors as a result of estimated changes in the cost of natural gas since it established its existing PGA rates last November in File No. GR-2020-0108 (tracking 2018-2019 PGA factors). File No. GR-2020-0372 was established to track Ameren Missouri's PGA factors to be reviewed in its 2019-2020 Actual Cost Adjustment (ACA) filing. On May 18, 2020, Ameren Missouri filed a substitute tariff. The tariff sheet bears an effective date of June 1, 2020.

The change in the PGA factor will decrease natural gas cost to \$0.3500/Ccf from \$0.3994/Ccf for residential and general service customers. The interruptible sales customers' PGA factor will decrease to \$0.2510/Ccf from \$0.2684/Ccf.

Staff of the Missouri Public Service Commission (Staff) filed its recommendation on May 22, 2020. No objections or other responses to the tariff filing or Staff's recommendation were received. Staff recommended the PGA factor rate changes be

approved on an interim basis, subject to refund, pending final Commission decision in this file and the final decision in Ameren Missouri's November 2019 PGA filing, File No. GR-2020-0108.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission finds that the proposed tariff sheets conform to Ameren Missouri's Commission-approved PGA tariff. In addition, because Ameren Missouri's PGA clause allows for PGA change filings to take effect on ten-days' notice,<sup>1</sup> good cause has been shown pursuant to Section 393.140(11), RSMo 2016, to permit the tariff to become effective on less than 30-days' notice. The Commission concludes the proposed tariff sheets should be approved to become effective on June 1, 2020, on an interim basis, subject to refund, pending final Commission decision in this file and File No. GR-2019-0108.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheet assigned Tracking No. YG-2020-0199 is approved on an interim basis and subject to refund, pending final Commission decisions in this file and in File No. GR-2019-0108. The tariff sheet approved is:
