**ORDER GRANTING EXTENSION OF TIME TO FILE STAFF REPORT**

On April 15, 2020, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (Evergy Metro) filed its 2019 Renewable Energy Standard (RES) Compliance Report and 2020 Annual RES Compliance Plan. By rule,<sup>1</sup> the Commission's Staff was required to review that Report and Plan and to file a report by June 1, 2020. Following discussions with Staff, Evergy Metro filed a revised Report and Plan on May 26, 2020. On May 29, 2020, Staff filed a motion for extension of time until June 12, 2020, to respond to the revised report. Staff represents that Evergy Metro does not object to the request for additional time to respond.

The Commission finds Staff's request for additional time to be reasonable and will grant that request.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file its Report regarding Evergy Metro's 2019 RES Compliance Report and 2020 Annual RES Compliance Plan no later than June 12, 2020.


