## ORDER SETTING TIME FOR RESPONSES

On June 3, 2020, Union Electric Company, d/b/a Ameren Missouri filed a Request to Amend Evaluation, Measurement and Verification Schedule, and Motion for Expedited Treatment requesting that the Commission extend the deadline for its contractor to file the Evaluation, Measurement, and Verification (EM&V) Final Report for the 2019 program year. According to the Ameren Missouri 2019-21 MEEIA Energy Efficiency Plan Report that was approved by the Commission on December 5, 2018, as part of a Stipulation and Agreement in this case, the EM&V 2019 program year Final Report is due on June 9, 2020. Ameren Missouri stated that it had discussed this extension with the Commission Staff and Staff has no objection to the extension, so long as the other deadlines are also extended.

The Commission will direct that any responses to Ameren Missouri's request and motion for expedited treatment be filed no later than June 5, 2020.

### THE COMMISSION ORDERS THAT:

1. Any responses to Ameren Missouri's request for extension and motion for expedited treatment shall be filed no later than June 5, 2020.

2. This order shall become effective when issued.
