ORDER RECOGNIZING NAME CHANGE

Issue Date: June 9, 2020

Effective Date: July 9, 2020

On May 27, 2020, Grain Belt Express Clean Line LLC filed a notice informing the Commission it is changing its name to Grain Belt Express LLC. In addition, Grain Belt applied for waiver of the 60-day notice requirement under Commission Rule 20 CSR 4240-4.017 and for waiver of the requirement to file an adoption notice and revised tariffs under 20 CSR 4240-2.060(5)(C).

The Commission's Staff on June 8, 2020, filed a recommendation advising the Commission to recognize the name change and grant the requested waivers. Staff advised Grain Belt has no tariffs on file with the Commission. The Commission will recognize the name change and grant the requests for waiver.

The Commission finds good cause exists to waive the 60-day notice requirement based on Staff's recommendation and Grain Belt's assertion that no substantive issues are presented to the Commission in this matter and there is no reason to delay recognition of the name change. Furthermore, Grain Belt is excused from any obligation to file an adoption notice and revised tariffs because Grain Belt has no tariffs on file with the Commission.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Grain Belt Express Clean Line LLC to Grain Belt Express LLC.
2. The notice requirement of Commission Rule 20 CSR 4240-4.017(1) is waived.
3. Because Grain Belt has no tariffs on file with the Commission, Grain Belt has no obligation to file an adoption notice and revised tariffs attendant to a name change.
4. This order is effective on July 9, 2020.
5. This file shall close on July 10, 2020.
