NOTICE OF CLARIFICATION

Issue Date: June 9, 2016

It has come to the Commission's attention that the Order Opening a Working Case to Consider Policies to Improve Electric Utility Regulation, issued on June 8, 2016, contains inconsistent dates for the filing of comments and responses to those comments. The first paragraph of the body of the order indicates initial comments are to be submitted by July 1, with responses to be submitted by August 1. Ordered paragraphs 5 and 6 of the order invite initial comments by July 8 and responses by August 8.

The Commission intended to allow 30 days after the order opening the case was issued for the filing of initial comments and another 30 days for the filing of responses to those comments. When the issuance of the order opening the case was delayed by a week, the dates in the ordered paragraphs were changed, but the dates in the body of the order were overlooked and were not changed. Interested stakeholders are invited to submit written comments by July 8, 2016, and written reply comments by August 8, 2016. The incorrect dates found in the first paragraph of the body of the order should be disregarded.
