**ORDER GRANTING REQUEST TO AMEND EVALUATION,  
MEASUREMENT, AND VERIFICATION SCHEDULE**

On June 3, 2020, Union Electric Company, d/b/a Ameren Missouri filed a Request to Amend Evaluation, Measurement and Verification Schedule, and Motion for Expedited Treatment requesting that the Commission extend the deadline for its contractor to file the Evaluation, Measurement, and Verification (EM&V) Final Report for the 2019 program year. The Ameren Missouri 2019-21 MEEIA Energy Efficiency Plan Report that was approved by the Commission on December 5, 2018, as part of a Stipulation and Agreement in this case, establishes time frames during which certain activities must be completed. According to that schedule, the EM&V 2019 program year Final Report was scheduled to be filed on June 9, 2020. Ameren Missouri states that its contractor requested an additional nine days to complete the Final Report for program year 2019.

Ameren stated that it had discussed this extension with the Commission Staff and Staff has no objection to the extension, so long as the other deadlines in the EM&V schedule are also extended. Ameren included a revised table showing the deadlines if the request for amendment is granted. The Commission directed that any other

responses to Ameren Missouri's request be filed no later than June 5, 2020. No responses were filed.

Having reviewed the unopposed request for an amendment of the EM&V schedule, the Commission finds it to be reasonable and will grant the request.

**THE COMMISSION ORDERS THAT:**

1. The request to amend the EM&V schedule found in the Commission-approved Ameren Missouri 2019-21 MEEIA Energy Efficiency Plan Report is granted.

2. The EM&V schedule is amended as follows:

July 7	July 16	Conference call regarding change request to impact evaluation if needed
July 21	July 30	Stakeholder group responses to impact change requests for PY19 are due to Commission
September 1	September 10	Evidentiary hearings for PY2019 complete
October 1	October 9	Recommended date for Commission order resulting change requests for PY 2019
