**JOINT STATUS REPORT**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), through counsel, and submits the following *Joint Status Report*:

1. On April 7, 2025, Staff filed *Staff's Complaint* in the above-captioned cause.
2. Respondent City Utilities of Springfield, Missouri ("CU") filed a *Motion to Dismiss* on April 24, 2025.
3. On May 15, 2025, Staff filed its Response to CU's *Motion to Dismiss*.
4. On May 23, 2025, the Commission ordered the parties to submit a joint procedural schedule no later than June 6, 2025, including dates for an evidentiary hearing.
5. On June 5, 2025, the Staff filed a *Motion for Extension of Time to File Joint Proposed Schedule*, citing the parties' attempt at resolving the matter.
6. That *Motion* was granted on June 5, 2025, and the parties were ordered to file a joint proposed procedural schedule, joint status report, or stipulation and agreement no later than July 7, 2025.

7. The parties are still in communication with each other regarding a possible resolution of this matter which may result in an amicable solution and need additional time to finalize their agreement.

8. As such, the parties request an additional 30 days within which to work to resolve the issues involved in this case and reach a mutually agreeable settlement agreement herein. All parties stated that they do not oppose this request.

**WHEREFORE**, Staff submits this status report for the Commission's information and requests an additional 30 days to provide the Commission with a joint proposed procedural schedule, joint status report, or stipulation and agreement, and for any other such orders and relief as the Commission sees just and reasonable under the circumstances.
