On June 5, 2025,<sup>1</sup> the Commission ordered the parties to file a joint proposed procedural schedule, joint status report or stipulation and agreement by July 7. On July 7, the Staff of the Commission (Staff) filed its *Joint Status Report*, requesting an extension of thirty days while the parties work to resolve the issues involved in this case.

The Commission finds this request reasonable and will grant the Motion.
