ORDER APPROVING COMPLIANCE TARIFF SHEET

Issue Date: July 8, 2025

Effective Date: July 23, 2025

On May 29, 2025,¹ the Commission issued a *Report and Order Approving Addendum to Territorial Agreement* (Order) in this matter, effective June 8. Among other things, that order directed The Empire District Electric Company d/b/a Liberty to submit revised tariff sheets by June 23 to reflect the change in its certificated service area in Christian County resulting from the order.

On June 23, Liberty filed a revised tariff sheet, purporting to be in compliance with the Commission’s Order. That tariff sheet was assigned Tracking No. JE-2025-0177 and had a proposed effective date of July 23.

At the Commission’s request, on July 7, the Staff of the Commission reviewed Liberty’s tariff sheet and filed its recommendation that the Commission approve the tariff sheet. Upon reviewing the pleadings, the Commission finds Liberty’s proposed tariff sheet complies with the Commission’s Order and will approve it. To enable the tariff sheet to become effective on the date requested by Liberty, the Commission finds it reasonable to make this order effective in less than 30 days.
