ORDER APPROVING TARIFF

On June 9, 2020, Union Electric Company d/b/a Ameren Missouri filed a tariff under Tariff Tracking No. YE-2020-0213 in compliance with the Commission's *Order Approving Partial Stipulation and Agreement* issued on May 28, 2020. The submitted tariff sheets bear a proposed effective date of July 9, 2020.

On June 17, 2020, the Commission's Staff filed a recommendation that the Commission approve the compliance tariffs. The Commission allowed until June 23, 2020 for any objections to the tariff filing or the Staff Recommendation. No party filed any response.

The Commission has reviewed the tariff filing and Staff's recommendation. The Commission concludes that the tariff should be approved.

THE COMMISSION ORDERS THAT:

1. The tariff sheets filed by Ameren Missouri on June 9, 2020, in Tariff Tracking No. YE-2020-0213, are approved to become effective on July 9, 2020.
2. This order shall become effective on July 9, 2020.
