On June 22, 2020,¹ Missouri Landowners Alliance and Gary Mareschal (Complainants) filed a Complaint with the Missouri Public Service Commission against Grain Belt Express Clean Line LLC, Invenergy Transmission LLC, and Invenergy Investment Company (Respondents). On June 23, the Commission issued its Notice of Formal Complaint and Order Directing Staff to File a Preliminary Report. On June 25, Respondents filed a Motion to Dismiss Formal Complaint. The Commission will issue its order requiring Complainants to file a response to the Motion to Dismiss.

THE COMMISSION ORDERS THAT:

1. No later than July 13, 2020, Complainants shall file a response to the Respondent's Motion to Dismiss.
