On November 12, 2019, Evergy Metro, Inc., d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc., d/b/a Evergy Missouri West (the Companies) filed a request for a variance from the Commission's billing and payment standards. The Commission issued an Order Approving Stipulation and Agreement on June 10, 2020.

To comply with the Commission's June 10, 2020 order, the Companies filed Tariff No. YE-2020-0217 on June 24, 2020. The tariff bears an effective date of July 24, 2020. The Commission will order its Staff's to file a Recommendation, and will allow other parties to respond.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file its Recommendation no later than July 7, 2020.
2. Any party who wishes to respond to the tariff or to Staff's Recommendation shall do so no later than July 10, 2020.
3. This order shall be effective when issued.
