Evergy Metro, Inc., d/b/a Evergy Missouri Metro, Evergy Missouri West, Inc., d/b/a Evergy Missouri West; the Commission's Staff, the Office of the Public Counsel, and Dogwood Energy, LLC filed a motion on June 30, 2020, asking the Commission to modify some of the terms of the stipulation and agreement regarding participation in the Southwest Power Pool by Evergy Missouri Metro and Evergy Missouri West, which the Commission approved in a June 19, 2013 order. Before ruling on the motion, the Commission will give the other parties an opportunity to respond.

THE COMMISSION ORDERS THAT:

1. Any party wishing to respond to the *Joint Motion of Evergy Missouri Metro, Evergy Missouri West, Staff of the Missouri Public Service Commission, Office of the Public Counsel, and Dogwood Energy, LLC to Modify Stipulations* shall do so no later than July 10, 2020.
2. This order shall be effective when issued.
