ORDER DIRECTING EXPEDITED FILING

On April 23, 2020,¹ Missouri-American Water Company (MAWC) filed tariff sheets with an effective date of May 23 under Tariff Tracking No. JW-2020-0185 to make the treatment of the customer service lines in MAWC's service area consistent with the rest of its service areas. On May 14 in order to give the Commission Staff time to develop its recommendation on the tariff sheets, the Commission suspended the tariffs until July 22. On June 30, the Staff filed its recommendation, recommending the Commission approve the tariffs. The Commission will issue an order requiring any objections or response to the Staff's recommendation or to the tariffs be filed no later than noon on July 6.

THE COMMISSION ORDERS THAT:

1. All objections or responses to the Commission Staff's June 30, 2020, recommendation or to the tariff sheets submitted under Tariff No. JW-2020-0185 shall be filed no later than noon on July 6, 2020.
2. This Order will be effective when issued.
