On April 8, 2020,¹ the Commission issued its Order Approving Transfer of Assets and Granting Certificate of Convenience and Necessity, approving a sale and transfer of water utility assets between the applicants whereby The Empire District Electric Company (Empire) would sell and transfer its water utility assets, including all contracts, agreements, franchises, and certificates of convenience and necessity (CCNs), to Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities (Liberty Water). Therein the Commission ordered Liberty Water to submit an adoption notice tariff sheet for the existing tariffs within ten days after closing on the assets, as a 30-day tariff filing for the existing Empire tariff. On July 9, 2020, Liberty Water filed an adoption notice tariff, YW-2021-0008, with an effective date of August 8, 2020. The Commission will issue its order requiring the Commission Staff to file its recommendation.

THE COMMISSION ORDERS THAT:

1. No later than July 20, 2020, the Commission Staff shall file a recommendation on tariff no. YW-2020-0008.
