ORDER APPROVING COMPLIANCE TARIFFS

Issue Date: July 20, 2020

Effective Date: July 30, 2020

On May 8, 2020,¹ the Commission issued an Order Approving Transfers of Assets and Granting Certificate of Convenience and Necessity to Liberty Utilities LLC (Missouri Water) (Liberty Utilities). The order required Liberty Utilities to submit an adoption notice tariff sheet for the existing tariffs within 10 days after closing on the assets and as a 30-day tariff filing, for the existing Empire tariff. Liberty Utilities filed Adoption Notice Tariff YW-2021-0008 on July 9 and a substitute on July 12 that included a title page, both bearing an effective date of August 8. On July 20, the Commission Staff filed its Tariff Adoption Notice Recommendation. After review of the substitute proposed tariff adoption notice and title page, Staff concluded they were in compliance with the Commission's order and recommended approval. The Commission will approve the compliance adoption tariff sheets in Tariff No. YW-2021-0008 issued on July 9, 2020, as substituted on July 12, 2020.

1. The compliance adoption tariff sheets in Tariff No. YW-2021-0008 issued on July 9, 2020, as substituted on July 12, 2020, are approved, with the tariff sheets to take effect on August 8, 2020.
2. This order shall be effective on July 30, 2020.
3. This file shall be closed August 9, 2020.
