## ORDER AMENDING PROCEDURAL SCHEDULE

Issue Date: July 23, 2020

Effective Date: July 23, 2020

The Commission previously set a procedural schedule for this matter. That schedule includes dates for filing an Issues List and Position Statements. After meeting with the parties' counsel in a prehearing conference on July 21, 2020, and in a telephone procedural conference on July 23, 2020, the Commission will amend the procedural schedule as set out below.

An evidentiary hearing in this matter is set for August 5-6, 2020. Due to the current COVID-19 pandemic, the hearing participants will be given the opportunity to participate either in person or using electronic means via video and/or telephone conference. To avoid the need for handling papers in the hearing room and to allow parties who may be participating electronically to have access to the documents used at the hearing, the parties will be required to provide all exhibits and presentations they intend to use in an electronic format to the Regulatory Law Judge and all parties prior to the hearing. This includes any rebuttal exhibits that may be used during cross-examination, if they are known. Additionally, in lieu of paper exhibits being handed to the court reporter at the

hearing, the parties will be required to email a copy those exhibits to Exhibits@psc.mo.gov at the time they are offered.

**THE COMMISSION ORDERS THAT:**

1. The procedural schedule is amended as follows:

Issues List, Order of Witnesses, Order of Cross-Examination      July 27, 2020

Position Statements      July 30, 2020

2. Participants shall appear at the evidentiary hearing either in-person or via video and/or telephone conference. The hearing will also be live-streamed via the Commission's website at psc.mo.gov. Interested persons who will not be actively participating in the hearing should access the hearing via the live stream. The link and access code to participate in the hearing via video or telephone conference will be emailed to all parties.

3. All exhibits and presentations that any party intends to use at the hearing shall be emailed to the Regulatory Law Judge and counsel for each party no later than 4:00 p.m. on August 4, 2020. The parties are assigned blocks of numbers in order to identify their exhibits as follows:
