**ORDER DENYING APPLICATION FOR REHEARING**

On June 17, 2020, the Missouri Public Service Commission issued a *Report and Order* effective June 27, 2020, regarding the application of Missouri-American Water Company to change an infrastructure system replacement surcharge. On June 26, 2020, the Office of the Public Counsel filed a timely application for rehearing.

Section 386.500.1, RSMo 2016, states that the Commission shall grant an application for rehearing if “in its judgment sufficient reason therefor be made to appear.” In the judgment of the Commission, the application for rehearing does not demonstrate sufficient reason to rehear the matter.

The Commission will deny the application for rehearing.

**THE COMMISSION ORDERS THAT:**

1. The Office of the Public Counsel's *Application for Rehearing* filed on June 26, 2020, is denied.
