On July 17, 2020, the Commission held a prehearing conference in this matter. During the conference, Complainant requested a hearing not be scheduled in this matter at this time unless an in-person hearing can be scheduled. Complainant offered to travel to Jefferson City if an in-person hearing can be conducted in the Commission's office. Counsel for Evergy Missouri West, Inc. d/b/a Evergy Missouri West and Commission Staff offered no objection to Complainant's request.

As discussed during the conference, the Commission will now direct the parties to propose dates to conduct a one-day evidentiary hearing in Jefferson City on or after September 1, 2020. The procedural schedule, now suspended, will be adapted to any hearing date ordered by the Commission.

1. No later than August 3, 2020, the parties shall submit a list or range of dates for a one-day evidentiary hearing to be conducted on or after September 1, 2020, at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri.
2. This order shall be effective when issued.
