<sup>1</sup> Section 392.550.3, RSMo., states that “[t]he commission **shall grant** a registration, without a hearing and no later than thirty days following the filing of an application accompanied by an affidavit signed by an officer or general partner of the applicant stating the following” list of requirements. (Emphasis added.) That list does not include a requirement to provide a certificate of good standing. The Commission notes, however, that according to the Missouri Secretary of State’s website, Good Methods Global Inc. is currently registered as a Foreign Corporation in good standing in the state of Missouri.
