## NOTICE REGARDING PRESENTATION TO COMMISSION

Issue Date: July 27, 2020

On March 18, 2020, in File No. ER-2019-0335, the Commission issued an Order Approving Stipulation and Agreement containing certain requirements for Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) with regard to making default time of use (TOU) rates available to residential customers with automated meter infrastructure (AMI). In File No. EE-2019-0382, Ameren Missouri has also filed exemplar tariffs and requests for waivers related to deployment of its AMI. Ameren Missouri intends to appear before the Commission at its regularly-scheduled agenda meeting on July 29, 2020, and provide an update on the status of the implementation related to these issues. During the presentation, the Commissioners will have an opportunity for to ask questions about the programs.
