NOTICE OF NONCOMPLIANCE

Issue Date: July 27, 2020

On June 22, 2020, Claude Scott filed a complaint with the Public Service Commission against Missouri-American Water Company (MAWC). On July 23, 2020, MAWC filed its answer and a motion to dismiss, citing Commission Rule 20 CSR 4240-13.070(7).

The Commission finds MAWC's motion to dismiss constitutes a request for summary determination, subject to Commission Rule 20 CSR 4240-2.117. MAWC's motion to dismiss does not comply with the requirements of that procedural rule.

Accordingly, the Commission will not take up the motion to dismiss as currently filed.
