On February 3, 2020, Spire Missouri, Inc., filed its application requesting a certificate of convenience and necessity to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Lafayette County, Missouri, as an expansion of Spire's existing certificated area. On May 6, 2020, the Commission issued its *Order Granting Certificate of Convenience and Necessity*, which directed Spire to file an updated tariff sheet to incorporate the described section of Lafayette County, Missouri. The Commission will now direct Spire to explain when such tariff sheet will be filed.

THE COMMISSION ORDERS THAT:

1. Spire shall file a response to the Commission's request above, which may include an updated tariff sheet, by no later than August 10, 2020.
2. This order shall be effective when issued.
