On July 13, 2020, Spire Missouri, Inc. (the "Company"), filed the above-referenced application. The application seeks, among other things, permission and approval and a certificate of convenience and necessity ("CCN") to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Cass County, Missouri, as a further expansion of the Company's existing certificated area.

The Commission issued notice of the application on July 14, and allowed potential intervenors until July 29 to request intervention. The Commission received no intervention requests.

The Commission will order its Staff to file a Recommendation.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a Recommendation no later than August 24, 2020.
2. This order shall become effective immediately upon issuance.


