ORDER REDUCING REPORTING REQUIREMENT

On February 28, 2025, The Empire District Electric Company d/b/a Liberty filed a true-up tariff revision to adjust its Securitized Utility Tariff Charge (SUTC). The accompanying filing letter informed the Commission that Liberty was short on funds and had to draw down its capital account and utilize the funds intended to pay the ongoing costs for 2024 to make the January 1, 2025, bond payment.

On March 19, 2025, the Commission issued its *Order Approving True-Up Adjustment Tariff and Request for Expedited Treatment*. That order directed Liberty to file a monthly report until such time as the Capitol Subaccount was replenished.

The filing letter accompanying Liberty's July 2025 monthly securitization report informed the Commission that "On July 1, 2025, the Company paid its semi-annual principal and interest payments. Additionally, the Company replenished its capital subaccount."

Liberty's securitization capital subaccount has been replenished. Therefore, the Commission will reduce Liberty's reporting requirement from monthly to quarterly until further order of the Commission.

THE COMMISSION ORDERS THAT:

1. Liberty is no longer required to file a monthly securitization report. Liberty shall file a securitization report every three months, starting from its July 2025 report, until further order of the Commission.
2. This order is effective when issued.

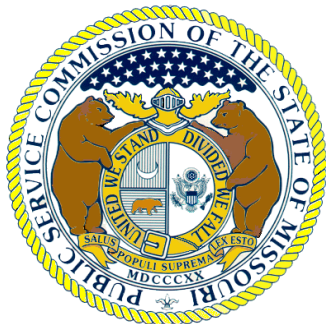
