ORDER DIRECTING STATUS REPORT

On August 10, 2023, the Commission opened a file for investigation of a natural gas pipeline incident that occurred on July 17, 2023, in Springfield, Missouri in an area served by the municipal gas system of City Utilities of Springfield (CU).

On December 11, 2024, the Staff of the Commission (Staff) filed a *Gas Incident Report* in this matter. At the request of the Commission, Staff filed a *Status Report* on March 24, 2025, indicating that it intended to follow-up with the filing of a complaint against CU.

The Commission will direct Staff to file another report on the status of the case.

THE COMMISSION ORDERS THAT:

1. No later than August 15, 2025, Staff shall file a status report on this matter, including whether it intends to file a complaint against City Utilities of Springfield.
2. This order shall be effective when issued.
