ORDER APPROVING TARIFF REVISION

On July 2, 2025, Evergy Metro, Inc. d/b/a Evergy Missouri Metro filed tariff sheets, assigned Tracking No. JE-2026-0002, to correct prior tariff sheets that were inadvertently not withdrawn. The corrective sheets bear an effective date of August 1, 2025. The Commission set a deadline for the Staff of the Commission to submit a recommendation and for any other comments on Evergy Missouri Metro's tariff sheets.

On July 16, 2025, the Staff of the Commission filed a recommendation that the Commission approve the tariff sheets. No other comments were received. Therefore, the Commission will approve the tariff sheets. So that the tariff sheets and order become effective on the requested tariff effective date, the Commission finds it reasonable to make this order effective in less than 30 days.
