ORDER APPROVING TARIFF REVISION

On July 2, 2025, Evergy West, Inc. d/b/a Evergy Missouri West filed tariff sheets, assigned Tracking No. JE-2026-0003, to correct prior tariff sheets that were inadvertently not withdrawn. The corrective sheets bear an effective date of August 1, 2025. The Commission set a deadline for the Staff of the Commission to submit a recommendation and for any other comments on Evergy Missouri West's tariff sheets.
