On July 30, 2020, Spire Missouri, Inc., filed a tariff sheet assigned Tariff Tracking No. YG-2021-0013, in compliance with the Commission's *Order Granting Certificate of Convenience and Necessity* issued on May 6, 2020, and *Order Directing Filing*, issued on July 30, 2020. The submitted tariff sheet bears a proposed effective date of August 29, 2020.

On August 4, 2020, the Commission's Staff filed a recommendation that the Commission approve the compliance tariff. No party has filed a response to Staff's recommendation.¹ The Commission has reviewed the tariff filing and Staff's recommendation and concludes the tariff sheet should be approved. To allow the compliance tariff to go into effect on the requested date, this order will be effective on August 29, 2020.
