## NOTICE OF TRANSFERRED PLEADING

Issue Date: August 14, 2020

Claude Scott filed a complaint against Missouri-American Water Company (MAWC) on January 6, 2020. A case was opened under File No. WC-2020-0194. The Commission dismissed the complaint on May 21, 2020, effective June 20, 2020. The file was closed on July 1, 2020.

On June 22, 2020, Mr. Scott filed a complaint against MAWC, and a case was opened under File No. WC-2020-0407. On August 10, 2020, Mr. Scott sent the Commission's data center an email. The subject line of the email referenced File No. WC-2020-0407. The email message stated only "Notice of intent to file Motion for Discovery. Mailed on August 10, 2020."<sup>1</sup>

On August 13, 2020, the Commission's data center received from Mr. Scott a *Motion for Discovery*. The filing references File No. WC-2020-0194, which is closed.
