## ORDER DIRECTING RESPONSES

On June 30, 2020, Missouri-American Water Company (Missouri-American) filed tariff sheets designed to implement a general rate increase for water and sewer services. On August 3, 2020, the parties met in a procedural conference. On August 13, 2020, Missouri-American filed a proposed procedural schedule and the other parties filed a separate proposed procedural schedule. The Commission would like more information in the form of a response from the parties about these proposals.

Therefore, the Commission directs Staff to respond (and the other parties may respond) to the procedural schedule set out by Missouri-American. The Commission also directs Missouri-American to advise the Commission as to how its proposed procedural schedule would change if the Commission does not order a future test year.

### THE COMMISSION ORDERS THAT:

1. No later than August 18, 2020, Missouri-American and Staff shall file responses as directed above.
2. Any other party wishing to respond shall do so no later than August 18, 2020.
3. This order shall be effective when issued.
