#### ORDER CLARIFYING PROCEDURAL SCHEDULE

Issue Date: August 18, 2020 Effective Date: August 18, 2020

On August 5, 2020, the Commission set forth the procedural schedule for the prudence review of Evergy Metro, Inc. and Evergy Missouri West, Inc. (collectively "Evergy"). On August 7, 2020, the Staff of the Missouri Public Service Commission ("Staff") requested clarification or modification of the procedural schedule.<sup>1</sup>

Staff's request stems from the schedule's setting of October 21, 2020, as the due date for Evergy's sur-surrebuttal, as well as the last day to issue discovery requests, issue subpoenas, or take depositions. Staff correctly points out this would preclude parties from conducting discovery concerning Evergy's sur-surrebuttal. That was not the Commission's intent.

Staff proposed two solutions, set forth below.

Option A: Delay the discovery cutoff date from October 21 to October 27, 2020, which would necessitate also delaying the hearing date by one week to November 12-13, 2020.

Option B: Delay the discovery cutoff date from October 21 to October 23, 2020.

Staff also noted that the procedural schedule sets September 12, 2020, a Saturday, as the due date for rebuttal testimony. The Commission's intent was to limit the schedule to business days.

Commission rules allow parties ten days to respond to pleadings unless otherwise ordered. Ten days have elapsed and no party has responded to Staff's request or proposed solutions.

The Commission finds Staff's request for clarification and modification to be reasonable and will grant it. For convenience, the schedule will be reprinted below, amended to implement Option B, and changing the due date for rebuttal testimony to September 11, 2020.

October 26, 2020	List of Issues, Order of Witnesses, Order of Cross-Examination Joint Stipulation of Facts

October 28, 2020 Statements of Position

November 5 - 6, 2020 Evidentiary Hearing

November 23, 2020 Transcripts due

December 11, 2020 Initial Post-Hearing Briefs

December 28, 2020 Reply Briefs
