ORDER APPROVING TARIFFS

Issue Date: August 26, 2020 Effective Date: September 10, 2020

On February 5, 2020, The Empire District Electric Company (Empire) and Liberty Utilities (Missouri Water), LLC (Liberty Water) (collectively "the Companies") filed an application for a variance of Commission Rule 20 CSR 4240-10.030(28) and accompanying tariffs to begin deployment of Advanced Metering Infrastructure (AMI) for electric and water customers. The Commission issued an Order Granting Variance and Approving Tariffs on March 18, 2020.

On August 11, 2020, the Companies filed tariff sheet revisions (YE-2021-0023 and YW-2021-0024) to explain that for AMI opt out customers, the Companies' default procedure will be to disable the two-way communication portion of the AMI meter. The use of non-AMI meters will continue to be an option for customers as long as those meters are available. The Companies state that these tariff changes have no impact on rates or charges.

The Commission ordered Staff to file its expedited recommendation regarding the tariffs by August 17, 2020, and ordered that any response to the tariff or to Staff's

recommendation be filed by August 19, 2020. Staff filed a recommendation that the Commission approve the tariffs. No other responses were received.

The Commission has authority to approve tariff sheets pursuant to Sections 393.140(11) and 393.150, RSMo. The Commission has reviewed the tariff sheets and Staff's recommendation. The Commission finds that the tariff sheets are consistent with the Commission's March 18, 2020 order, and should be approved. To allow the substitute tariff sheets to take effect on September 10, 2020, the Commission will issue its order with an effective date fewer than 30 days from the date of issuance.

THE COMMISSION ORDERS THAT:

1. The tariff sheet filed by Empire on August 11, 2020, and assigned Tariff No. YE-2021-0023, as substituted on August 15, 2020, is approved to become effective on September 10, 2020. The tariff approved is:
