ORDER GRANTING ADDITIONAL TIME TO FILE STAFF RECOMMENDATION ON COMPLIANCE TARIFFS

On August 12, 2020, the Commission ordered its Staff to file a recommendation regarding The Empire District Electric Company's (Empire) compliance tariffs no later than August 31, 2020. On August 31, 2020, Staff filed a motion for an extension of time to file its recommendation. Staff seeks an extension of one day to allow Empire to file substitute tariff sheets based upon Staff's discussions with Empire prior to Staff filing its recommendation.

The Commission will grant the requested extension. The Commission will also extend the time for other parties to respond to Staff's recommendation or Empire's tariffs by one day.

THE COMISSION ORDERS THAT:

1. The Commission's Staff shall file its recommendation regarding Empire's compliance tariffs no later than September 1, 2020.
2. Any other comments or recommendations regarding Empire's compliance tariffs or Staff's recommendation shall be filed no later than September 3, 2020.

3. This order is effective when issued.
