**ORDER EXTENDING TIME FOR
FILING OF STAFF RECOMMENDATION**

Effective Date: September 2, 2020

On April 17, 2020, The Empire District Electric Company, a Liberty Utilities company (Empire-Liberty) filed an application for approval of a Community Solar Pilot Program.¹ Contemporaneously therewith, Empire-Liberty filed an implementing tariff, which bears an effective date of June 1. The Commission issued notice, and ordered its Staff to file a Recommendation no later than May 7.

On April 29, Empire-Liberty extended the effective date of the tariff to August 1 to give the parties additional time for review. Staff requested until July 6 to file a Recommendation. The Commission granted Staff's request.

Empire-Liberty then extended its tariff effective date to October 1. The Commission ordered Staff to respond no later than September 4.

On September 1, Empire-Liberty extended its tariff effective date to October 15. The Commission will allow more time for Staff to file its Recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a Recommendation on the pending tariff no later than September 18, 2020.
2. Any response to the Staff Recommendation shall be filed no later than September 24, 2020.
3. This order shall be effective when issued.


