## ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

Effective Date: September 2, 2020

On September 1, 2020,<sup>1</sup> Spire Missouri Inc. d/b/a Spire Missouri East and Spire Missouri West filed an Application to Update its Weather Normalization Adjustment Rider (WNAR) per sheets in Tariff Tracking Numbers JG-2021-0051 and JG-2021-0052. Spire projects the changes to the WNAR tariff sheets will increase the monthly bill for the average Spire East residential customer by approximately \$0.75 per month, and the monthly bill for the average Spire West residential customer by approximately \$0.70 per month.

The tariff sheets filed under JG-2021-0051 and JG-2021-0052 bear an October 1, 2020, effective date. The Commission will direct the Staff of the Commission to file a recommendation, and will establish a deadline for any other entity to file a response to the proposed tariff changes.

### THE COMMISSION ORDERS THAT:

1. No later than September 11, 2020, the Staff of the Commission shall file a recommendation regarding Tariff Tracking Nos. JG-2021-0051 and JG-2021-0052.
